## Specific conditions related to this permit:

1. This Permit and attached conditions shall be kept on site during the project.

## **General Conditions:**

- The Salt Lake County Health Department's Noise Curfew begins at 10 p.m. and ends at 7 a.m. the following morning, 365 days a year, throughout Salt Lake County. All activities, unless directly given relief for within this permit, are prohibited during the noise curfew, unless otherwise exempted within the Department's Community Noise Pollution Control Regulation.
- 2. All residential dwellings, hotels, motels, RV parks, and other adversely affected commercial facilities within 800 feet of the permitted area shall be given a notice at least 48 hours ahead of the scheduled activities. This notice may be distributed either by mail or posted on each property and shall include a description of the activities, the date, time and duration of the event(s), and the name and cell phone number of an onsite contact person who has the authority to address and help minimize any concerns that may arise.
- Only work specific to the activities listed is permitted to occur while this permit is in effect. All other
  operations shall occur during the daytime hours which begin at 7 a.m. and continue until 10 p.m., unless
  otherwise specified.
- 4. All motorized vehicles, including construction equipment, shall not stand idle in excess of 2 minutes to control air emissions.
- 5. Every effort shall be made to keep the noise level as low as possible. This includes, but is not limited to:
  - a. No music.
  - b. Proper use of communication equipment.
  - c. Installing and maintaining noise attenuating equipment in good working order.
  - d. Routine inspection and maintenance of any equipment or vehicle used during the activities including the engine, belts, joints, bearings, and muffler to ensure they are in good working condition.
  - e. Proper staging for waiting delivery vehicles.
  - f. Not allowing vehicles to idle unnecessarily.
  - g. Appropriate yet minimal signaling measures.
  - h. Establishing proper loading and unloading procedures including site delivery routes and staging to minimize backup warning devices as required by federal law.
  - i. When portable lighting units are used, they shall be kept away, as well as pointed away from surrounding properties, especially residential.
- 6. All traffic control measures including temporary traffic control signals, arrow, and message boards shall be electrified by the local power utility or be solar and or battery powered.
- 7. An original or copy of this permit shall be made available for review on the job site by anyone while in effect. It shall not be altered or transferred to another party and is in effect only at the specified location. Please contact my office if changes are necessary.
- 8. This permit grants relief from the local noise restrictions ONLY. You shall comply with all other federal, state, and local ordinances, rules, or regulations.
